FS2000 - DAILY MAINTENANCE

Make sure the FS2000 lid is securely in place - The lid should only be removed to empty and clean the FS2000.

Empty and clean the inside of the FS2000 at least once a week - Removing the solid and food waste that may be in the bottom.
